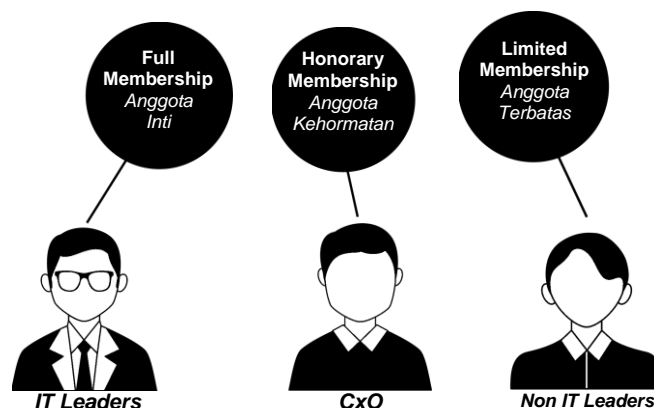
Our Mission

Our Membership Categories
